

1. New Director of Research and Development at Whittington

Professor Monty Mythen joined the Whittington on 23 July 2007 as Director of Research and Development. This appointment is a six-month secondment from the UCL, Institute of Child Health.

As the Whittington's Director of Research and Development Professor Mythen's key objective will be to oversee the implementation of the review of the Whittington's research function that was approved at the February meeting of the Trust Board. At the end of his six month secondment, he will also make recommendations for the ongoing leadership arrangements for research and development at the combined Whittington and UCL Archway Campus.

Monty Mythen brings a wealth of experience to the role, having made a major contribution to the development of the successful bids to establish UCLH as a Comprehensive Biomedicine Centre and Great Ormond Street Hospital as a Specialist Biomedicine Centre.

2. NHS London: Provider Agency performance monitoring regime

The Trust's annual plan, submitted in April this year, is subject to regular monitoring by the strategic health authority's provider agency. The form of this monitoring is based on the Monitor model, which uses the information provided to assess performance under four key headings. The first quarter position was reported at the end of July, comprising detailed financial returns, a summary analysis of performance against key targets with accompanying narrative on the principal risks. The outcome of the Provider Agency review assigned the following risk ratings:

Financial risk rating 4 on a scale of 1 – 5 (where 5 is the best|)

Governance Green (traffic light system)

Services provided Green

Quality and safety Amber (resulting from MRSA trajectory performance)

This represents an improvement in the financial risk rating in the original plan from 3 to 4. All other ratings have remained the same. Overall this is judged to be good performance and means that we shall be placed on quarterly rather than monthly monitoring. The results for all London trusts covered by the Provider Agency are due to be posted on their website and will be reported to the Board if available.
