1. Primary Care Trusts single acute commissioning function

World class commissioning is an essential element of the next stage review of NHS system reform and PCT functions are being revised to enable this change in function. To deliver the changes required to implement Healthcare for London, arrangements are being made for acute services commissioning to be changed. In north central London local PCTs will continue to operate as statutory organisation, however a separate agency will undertake acute commissioning on their behalf. The agency will be chaired by one of the PCT chairs and led by an officer of status equivalent to Chief Executive. It is intended to appoint the lead officer by November and to have a team in place by January. PCTs will delegate accountability for agreeing contracts, performance and expenditure to the head of the agency.

This sector level arrangement will be complemented by an NHS London 'expert support and shared services hub' which will work on functions such as capacity planning and care pathway design for specialised services. This function will also provide health economics advice. NHS London has recently established a 'Commissioning Support Service' for London PCTs: the relationship between these agencies is yet to be described.

Issues that may arise from this change include:

Fracturing of well developed commissioning relationships

Loss of understanding by commissioners of Trusts as organisations, their services and contract arrangements

Delays in decision making due initially to inexperience and long lines of Governance

The Board will continue to be informed of this development as it progresses through the year.

6. Single sex accommodation

In 2007, the Chief Nursing Officer published "Privacy and Dignity – a report into mixed sex accommodation in hospitals", outlining the improvements that needed to be made in the NHS to ensure full compliance with the standards on the provision of single sex accommodation. When the original standards for single sex accommodation were published, as part of the 1992 Patients' Charter, some areas were exempt from reporting on compliance, namely intensive care units and high dependency areas. Since 2007, that exemption has been lifted, and all areas are now expected to report compliance with the standards.

Earlier this year, Trish Morris-Thompson, Chief Nurse for NHS London, wrote to all acute trusts requiring them to advise their trust boards of all breaches in the provision of single sex accommodation within their organisations.

Daily monitoring is in place at the Whittington Hospital, and senior managers are informed each morning of any areas that are not complying with the single sex accommodation criteria, by the bed management team. There are three areas within the hospital that have at times accommodated male and female patients together over the last two months:

Mary Seacole Ward (acute admissions) – the ward has two five-bed rooms, in addition to its five single rooms. Due to the nature of admissions from the Emergency Department, one of the five-bed rooms is regularly occupied by both male and female patients. Patients are on the ward for approximately 24 hours, before being transferred to a main ward in the hospital, which complies with the best practice guidance from the DH.

The Coronary Care Unit on Montuschi Ward has six beds and routinely accommodates both male and female patients as required. The beds are in a line, separated by curtains, all facing the same way towards the nurses' station, which also complies with best practice guidance.

Nightingale Ward has three four-bed rooms, one of which is used to nurse respiratory patients requiring high dependency care. There have therefore been a number of times over the past two months when both male and female patients have been nursed in this area. Patients may remain in this area for longer than 24 hours, depending on their clinical condition, and are moved to one of the other rooms when they no longer require close observation nursing care.

There will be a report to every future trust board meeting outlining breaches in compliance with the single sex accommodation guidelines, as required by NHS London.
