Chief Executive's Report to the Board

19 December 2012

1. Introduction

The purpose of this report is to update the board on local, regional and national policy changes that will affect the organisation and sets out the key issues facing the Trust.

2. The Chancellor's Autumn Statement

The statement delivered to Parliament on 5 December contained no major changes for the NHS. Public finances will continue to be affected by prolonged austerity. Key points for the NHS include:

- spending on health will continue to be protected unitl 2015/16
- national pay arrangements will continue in the NHS
- new Government proposals for making private finance initiative (PFI) more transparent, flexible and efficient, the so called PF2 policy.

3. Secretary of State's top four priorities

The Secretary of State for Health, Jeremy Hunt, has updated his top four priorities. In a blog (http://tinyurl.com/cvh9np8), he has refined "improving the care for people with long-term conditions like diabetes, asthma and arthritis" with "bringing the techology revolution to the NHS" and to use techology to improve shared decision making for people with long term conditions. The other three priorities are:

- Improving mortality rates for the big four killer diseases: cancer, stroke, heart, liver and respiratory disease
- Improve the standard of care throughout the system
- Transforming our care and treatment for people with dementia

4. Digital First strategy

On 26 November the Government published "Digital First – the delivery choice for England's population" strategy (http://tinyurl.com/btcsvew) which sets

out 10 easy win initiatives which the NHS can achieve today to save £2.9 bn. The recommendations that are in our 2017 Vision include:

- Reducing unnecessary Secondary Care appointments by using online preconsultation screening and video-based remote consultations. This will not only improve patient convenience, it will reduce unnecessary face-to-face consultations for Secondary Care & post-surgical follow ups
- More efficient appointment booking by using *online booking systems* to increase convenience for patients and reduce administration costs
- Reducing DNAs by improving our use of digital notifications and reminders can avoid unnecessary waste of resources caused by DNAs
- Reducing costs of notifying test results using channels such as SMS for notification of negative test results will save the costs of unnecessary faceto-face appointments
- Reducing cost of letters using email as a default option can save significant costs from sending patient letters

5. CNO's strategy for nursing, midwifery and care staff

A new three year vision and strategy for nursing, midwifery and care staff was launched on 4 December by the Chief Nursing Officer. Called "Compassion in Practice" (http://tinyurl.com/cong7cl) the vision is based around six values - care, compassion, courage, communication, competence and commitment. The vision aims to embed these values, known as the Six C's, in all nursing, midwifery and care-giving settings throughout the NHS and social care to improve care for patients.

6. **Authorisation of first wave Clinical Commissioning Groups**

The NHS Commissioning Board authorised the first wave of clinical commissioning groups (CCGs) on 11 December. Islington is one of the 35 CCGs which passed the national test to take on budgets for secondary care. Each CCG was tested against 119 criteria and if any was not met, it was listed as a "condition". Overall, eight CCGs were authorised without conditions; 26 were authorised with between one and 14 conditions, and one was deferred. Islington CCG was authorised with one minor condition.

7. Dr Foster's 2012 Hospital Guide

In addition to publishing traditional mortality indicators, this year's Hospital Guide (http://tinyurl.com/cmghwqw) highlights information on the vital link between quality and efficiency. The Whittington Hospital had a Hospital Standardised Mortality Ratio (HSMR) of 79, making us one of the safest hospital in the country. We scored average for efficiency. The guide, which benchmarks the performance of every hospital trust in England, also found:

- most hospitals are more than 90 per cent full at midweek; in winter, many hospitals are more than 95 per cent full.
- nearly 29 per cent of hospital beds are occupied by patients whose hospital stay might have been avoided; a lack of integration with social and community care is often the problem.
- mortality rates continue to improve, although 12 trusts were highlighted as causes for concern.
- the rapid rise in admissions among frail elderly patients over the last five years has created a demand for hospital beds.

8. Key staff leaving
