1. Purpose and Key Responsibilities

The purpose of the Whittington Health Transformation Board is:-

- To seize the opportunity of being a new integrated care organisation to transform how care is delivered for our population
- To take an overview of contract delivery for 2013/14 to assure achievement of the £212m exit run rate by the end of 2013/14.
- Help manage economy wide risk across host commissioners, Haringey and Islington CCGs and Whittington Health.
- Identify initiatives to deliver the required Integrated Care and QIPP savings within agreed contract values.
- Identify initiatives to mitigate any savings shortfall within agreed contract values.
- Maximise the value added to the health economy through the application of £8.9m transitional funding support over the two-year contract to deliver improvements in productivity and reduction in activity levels.
- Support Whittington Health attain Foundation Trust status in 2013/14
- Agree and pursue a work plan to deliver the above

The key objectives are:

- To provide a strategic overview of services delivered by Whittington Health and to lead the change for service improvements on behalf of the stakeholder organisations, looking forward until 2015/16.
- To set a programme of service redesign work for the respective organisations until 2015/16.
- To determine how to commission services differently.

- To ensure Whittington Health continues to develop as an integrated care organisation, and to ensure it maintains and improve performance.
- To work in partnership to deliver the respective stakeholder organisations objectives
- To deliver a more productive use of resources, whilst maximising best value for money for our population,
- To align priorities across health and social care

It is responsible for:

- Overseeing and monitoring the delivery of agreed schemes through existing contract and project working.
- Receiving regular progress reports from the project leads, and ensuring that key indicators, outcomes and milestones are achieved
- Reviewing the financial opportunities and risks log and ensuring appropriate actions are being taken to manage any overall financial risks.
- Regular progress reporting to Islington Strategy and Finance Committee, Haringey Strategy and Finance Committee, Whittington Health Executive Team.
