# 3. Clinical Negligence Scheme for Trusts level 2

The Whittington is delighted to have achieved level 2 compliance with the CNST General Clinical Risk Management Standards at this assessment earlier this year. The litigation authority says that this result is well deserved as it reflects positively on the enormous amount of work undertaken since the last assessment. The authority says:
